I am directed to refer to UGMEB's letter of even number dated 24.05.2024 regarding granting renewal permission of 100 MBBS seats for the AY 2024-25 subject to either payment of fine of Rs.12,00,000/- (Rupees twelve lacs only) or prefer first appeal before Chairman, NMC in accordance with NMC Act 2019.

2 It is observed that your College has neither deposited the penalty amount nor preferred First

Appeal as mentioned in the above said letter issued by UGMEB towards the renewal permission for the AY 2024-25. As the counselling for admission in MBBS is likely to be started soon and due to paucity of time for exhausting the appeal process, it has been decided to grant permission for renewal for the AY 2024-25 with existing number of MBBS seats permitted for the year 2023-24.

3. Chapter III, clause 8.2(f) provides the provisions for *reducing the number of students in the next or subsequent academic years to be admitted by the Medical Institutions.* Accordingly, it has been decided by the Competent Authority to take further *stringent action against your college/Institute as per relevant clauses of MSMER 2023 including seat reduction for next AY 2025-26 in case of failure to deposit the penalty amount OR not preferring the appeal within the prescribed time frame.* 

4. In view of the above, you are directed to remit the penalty amount immediately and forward confirmation of payment along with transaction details t o ug.scn@nmc.org.in.**Please treat this as most urgent and important.** 

5. It has been further observed that the colleges are requesting UGMEB to waive off the penalty. In this regard it is clarified that no such request shall be responded by UGMEB, NMC. If the college is aggrieved by the decision of this board, it may prefer First Appeal before the NMC as communicated in the earlier letter also.
